Directions (1 - 5): Read the given information carefully and answer the following questions.

Nine persons of a family are working on nine different designations in the company viz. CMD, CEO, COO, CFO, MD, Senior Manager (SM), Associate manager(AM), Supervisor, and Trainee. All the designations given are to be considered in a given order (as CMD is considered as Seniormost and Trainee are considered as the Juniormost). There are only three married couples in this family. Either both or no parent is alive. All of them get different awards- Leadership award, Best performance award, and Teamwork award.

Two persons work between S and his wife. X works on three posts higher than W. The number of persons senior to X is one more than the number of persons junior to R who is the brother-in-law of U. S has only two children. Only S and his daughter got the best performance award. R is the nephew of T who is not the sibling of P. Q is the sister-inlaw of V and got the leadership award. Not more than three persons are senior to S who is not the CEO. Four persons work between W and S who is the grandfather of W. Parents of W got the same award but not as same as W. Only one person works between P and T who is junior to P and got the Teamwork award. Neither P nor V is AM of the company. V is the aunt of X whose sister got the Teamwork award. Number of males are one more than the number of females in this family. X and U got the same award but not as same as R. U and W got the same award. P, V, and T, all of them got different awards. Q is just junior to U who is the son-in-law of S but not the father of W. Neither Q nor U is CMD.

Directions (6 - 10): Read the given information carefully and answer the following questions.


21 persons work in an organization at a different post. The posts are in decreasing order i.e. Executive Director (ED), General Manager (GM), General Manager(DGM), Assistant Manager (AM), and Clerk. The number of person posted were one less than the number of persons posted in the immediate junior post. For example: If 4 persons work as AM then 5 persons work as a Clerk.

D, E, and H are working together in a post which is senior to AM. M, P, L, and N are working together in a post. B is working in a post which is just junior most to K. The number of persons working above H is the same as the number of persons working below K. S is senior to X who is senior to both V and C. Both R and N are senior to V. U and T are working together in a post which is senior to L. N and R are not working in the same post. X is senior to both Q and W. Q is working below the post of DGM. Neither Q nor X is working as GM. F and G working together in a post and they are senior to R who is junior to both T and S. C is junior to S but not senior to A. G is senior to T.

Answers and Solutions

- (Q:1 Q:5): 1. Not more than three persons are senior to S who is not the CEO. (There are two possibilities).
- 2. Four persons work between W and S who is the grandfather of W.
- 3. X works on three posts higher than W.
- 4. The number of persons senior to X is one more than the number of persons junior to R who is the brother-in-law of U.
- 5. Q is just junior to U who is the son-in-law of S but not the father of W.
- 6. Neither Q nor U is CMD. (From this condition possibility of S is COO has been cancelled).
- 7. S has only two children.

- 8. Only S and his daughter got the best performance award. (Case 2 gets canceled)
- 9. Two persons work between S and his wife.
- 10. R is the nephew of T who is not the sibling of P.
- 11. Q is the sister-in-law of V and got the leadership award.
- 12. Parents of W got the same award but not as same as W. (from this condition case 2 in the blood relation tree has been canceled because in this case, possible couples are four).
- 13. Only one person works between P and T who is junior to P and got the Teamwork award.
- 14. Neither P nor V is AM of the company.

From the above conditions, it is clear that P is the wife of S, and T is the sibling of S.



- 15. V is the aunt of X whose sister got the Teamwork award. (Hence W and X are the children of Q)
- 16. Number of males are one more than the number of females in this family.
- 17. X and U got the same award but not as same as R. U and W got the same award. P, V, and T, all of them got different awards.

Hence Q and R got the leadership award, V got the Best performance award and X and U got the teamwork award.

Q:3 The correct answer is Option 2 i.e. Aunt

From the above arrangement, W works as a trainee and V is the aunt of W.

Hence, the correct answer is Aunt.

Q:4 The correct answer is Option 4 i.e. Five

From the above arrangement, U is the son-in-law of P and five persons work between U and P.

Hence, the correct answer is Five.

Q:5 The correct answer is Option 2 i.e. SM

From the above arrangement, X is the son of Q and works as SM.

Hence, the correct answer is SM.

Hence, the correct answer is 5.
